

Wayfair's Way Day Home Makeover Sweepstakes Official Rules

PROMOTION PERIOD: The Way Day Home Makeover Sweepstakes ("Promotion") begins on **October 18, 2023 at 7:00 AM Eastern Time ("ET")** and ends at **3:00 AM ET on October 27, 2023 (the "Promotion Period")**. The computer clock of Wayfair LLC ("Sponsor") is the official time-keeping device in the Promotion.

ELIGIBILITY: The Promotion is open only to legal residents of the 50 United States and the District of Columbia (excludes Guam, Puerto Rico and all other U.S. territories and possessions) who are 18 years of age or the age of majority, whichever is older as of the date of entry. Employees, officers, and directors of Sponsor, Serta ("Prize Provider"), and their parents, affiliates, subsidiaries, and advertising, contest, fulfillment, and marketing agencies (collectively, the "Promotion Parties"), their immediate families (parent, child, sibling & spouse and their respective spouses, regardless of where they reside) and persons living in the same households as such individuals (whether related or not) are not eligible to participate in the Promotion. HOW TO ENTER: There are two ways to enter the Promotion. To enter the Promotion, you must either:

- (i) Make a purchase on Wayfair.com during the Promotion Period; or
- (ii) Mail-In Method of Entry: To enter the Promotion without making a purchase, you may submit a mail-in entry. To enter via this method, handwrite your first and last name, street address, phone number and email address on a piece of paper, insert the paper in a #10 envelope and mail your entry via first-class mail to: Wayfair LLC, 4 Copley Place, Boston, MA 02116, Attn: Promotions. Each mail-in entry must be mailed separately. Wayfair is not responsible for late, lost, damaged, illegible or postage-due mail. To be eligible, your mail-in entry must be postmarked during the Promotion Period and received within seven (7) days after the end of such Promotion Period.

Each purchase or mail-in entry will equal one (1) entry, with no limit on the maximum number of entries during the Promotion Period. Any attempt by any Entrant to submit more than the stated number of Entries allowed by using multiple or different email addresses, identities, accounts, registrations and logins, or any other methods will void that Entrant's Entries and that Entrant may be disqualified.

CRITERIA FOR WINNER SELECTION: A total of one (1) Prize (defined below) will be awarded to one (1) potential winner in an electronic, randomized drawing. The drawing for the potential winner will be held on November 6, 2023. The drawing will be made from all eligible entries received during the Promotion Period. The drawing will be conducted by Sponsor or Sponsor's third party administrator, whose decisions are final and binding in all matters relating to the Promotion.

The potential winner is subject to verification by Sponsor. An entrant is not a winner of the Prize unless and until entrant's eligibility has been verified and entrant has been notified that verification is complete.

PRIZE: The Prize will consist of the following:

Fifty thousand dollars (\$50,000) in Wayfair Gift Card to be applied to the winner's wayfair.com account, subject to the Wayfair Gift Card Terms and Conditions, available at https://www.wayfair.com/customerservice/general_info.php#gcterms.

Up to twenty (20) Hours of Design Services to be used within one (1) year of winner selection.
Approximate Retail Value: one thousand dollars (\$1,000).

Total Approximate Retail Value: fifty-one thousand dollars (\$51,000.)
